From the material available on record, prima facie case is made out for an offence under Section 302 IPC against Amit Sharma accused and as against the remaining seven accused, prima facie case is made out for the same offence with the aid of Section 149; for an offence under Section 307 IPC against Prakash accused and as against the remaining seven accused, prima facie case is made out for the same offence with the aid of Section 149; for an offence under Section 326 IPC against Amit Nayak accused and as against the remaining seven accused, prima facie case is made out for the same offence with the aid of Section 149; for an offence under Section 326 IPC against Prince accused

and as against the remaining seven accused, prima facie case is made out for the same offence with the aid of Section 149; for an offence under Section 323 IPC against Himanshu, Montu, Tarush and Danish accused and as against the remaining four accused, prima facie case is made out for the same offence with the aid of Section 149.

Let charge be framed accordingly.
