Sh. Sultan, the father of accused Deepak Kumar @ Bhuri (A-2), has moved an application submitted that A-2 has been shot at. Accordingly, he has sought permission. Copy of application given. Put up for reply on this application.

Accused Rajesh @ Marry (A-1) and Deepak Kumar @ Arav (A-6) are absent. Issue their non bailable warrants and notices under Section 446 CrPC to their sureties for **28.7.2018**.

Accused Virdner Kumar @ Bunt (A-3) has moved an application for release of motorcycle no. DL5SBU0965, Splender PRO, one mobile phone Samsung black, one mobile phone Tata Indicom Black, one Purse/wallet including Rs.25000/-, RC of above motor cycle and other important documents and one ear ring.

Reply was filed on 16.5.2018 in which it was stated that cash Rs.1,05,000/- along with one motorcycle bearing No. DL5SBU0965 Hero Honda Splendor PRO DRS was recovered from accused Virender, cash Rs.1,07,000/- from Rajesh, Rs.1,15,000/- from Deepak and Rs.1,03,000/- from Pankaj. The above mentioned accused had been produced by the official of Crime Branch before the court and were formally arrested in the said case.

It was further stated in the reply that the motorcycle Hero Honda Splendor PRO bearing registration no. DL5SBU0965, which was used in the commission of crime in the present case, was taken into the police possession by the Crime Branch, Central Range, New Delhi under Section 102 CrPC vide DD no. 17 dated 2.10.2015. At present, the above mentioned motorcycle is lying in the Malkhana of this police station. The articles i.e. one mobile phone Samsung Black, one mobile phone Tata Indicom black, one purse/wallet including Rs.25,000/-, RC of the above motorcycle and other important documents as mentioned by the applicant in present application were not seized in the case as per record available.

Today SI Prem Kumar has filed reply that motorcycle no. DL5SBU0965 is registered in the name of accused Virender @ Bunty (A-4). Therefore, let this motorcycle be released on superdari to applicant/accused Virender @ Bunty (A-4) on furnishing superdarinama in the sum of Rs.20,000/- subject to the condition that he shall file the photographs of the vehicle depicting its number plate clearly and subject to the condition that he shall produce the vehicle in the court as and when required.

In respect of remaining articles, the matter would be considered on next date i.e. 28.7.2018. Investigating officer be summoned for that date.
