Accused persons namely Virender [Kumar@Bunty](#), Pankaj and Afasal are present on bail.

Two separate application for cancellation of NBWs against accused persons namely Deepak [Kumar@Arav](#) and [Divesh@Deepu](#) have been filed.

Ld. Counsel for accused persons namely Deepak [Kumar@Arav](#) and [Divesh@Deepu](#) submits that wife of Deepak [Kumar@Arav](#) was admitted in hospital and accused [Divesh@Deepu](#) had met with an accident. This court was not informed about the same and accused persons were also not found at their given addresses. Conduct of both accused persons is taken on record.

In view of the facts and circumstances of the case, NBWs issued against both the accused persons namely [Deepak Kumar@Arav](#) and [Divesh@Deepu](#) stands cancelled subject to payment of cost of Rs. 1,000/- by each accused with DLSA. Cost has been deposited by both the accused persons and the receipts has been filed before the Court. Same are taken on record.

Both the accused persons and their sureties are warned to be careful in future.

Smt Barkha W/o accused Rajesh@Marry has appeared before this Court. She submits that accused Rajesh@Mary has been lodged in Jail in case FIR no. 166/2018, PS Shakarpur. **Let production warrant of accused Rajesh @Mary S/o Raj Kumar be issued for NDOH.**

On the LDOH were issued against accused Deepak [Kumar@Bhuri@Chirag](#). Report has been received that the NBWs against Deepak [Kumar@Bhuri@Chirag](#) could not be executed as he has been logged in Jail in case FIR no. 293/2020 PS Laxmi Nagar. **Issue production warrant of accused Deepak [Kumar@Bhuri@Chirag](#) for the NDOH.**

Matter is fixed for PE.

No PW is present.
