Accused Pankaj is PO.

Accused persons namely Divesh @ Deepu, Virender Kumar @ Bunty, Deepak Kumar @ Arav and Afzal are present on bail.

Accused persons namely Rajesh @ Marry produced from J.C. (although on bail in present case).

Accused Deepak Kumar @ Bhuri @ Chirag produced from J.C. (although on bail in the present case).

Sh. Om Prakash, Ld. Counsel for all accused persons except accused Rajesh @ Marry.

None for accused Rajesh @ Marry.

Matter is fixed for PE.

PW-10 Retd. ASI Kallu Singh and PW-11 HC Satender examined-in-chief, cross-examined on behalf of all accused persons except accused Rajesh @ Marry. The cross-examination of abovesaid witnesses has been deferred on behalf of accused Rajesh @ Marry as he has not yet engaged a counsel despite the fact that the previous counsel had withdrawn his Vakalatnama on last date of hearing, **subject to payment of cost of Rs. 2,000/- to be deposited with DLSA, Central.**

On the last date of hearing summons were sent to Nodal Officer, Tata Tele Services which has already shut-down its operation and has merged with Bharti Airtel Ltd., through IO.

IO/Inspector S. K. Gupta is stated to be on leave and he has not served the summons upon the concerned Nodal Officer.

Let the fresh summons be issued to the concerned Nodal Officer, for next date of hearing, through IO/Inspector S. K. Gupta.

Issue notice to IO/Inspector S. K. Gupta with the direction to appear in person and file an explanation in this regard, on next date of hearing.

Report has been filed on behalf of Jail Superintendent. As per the report, in view of safety and security of Jail as well as considering the basic requirement of inmate soft sole without laces shoes and sleepers have been made available for the inmates in the jail canteen. The inmate cannot be forced to purchase the shoes/sleepers from the jail.

Accordingly, Jail Superintendent is directed to allow the inmate to get soft sole without laces shoes from his family members/relative through Mulaqat.

Put up for payment of cost by accused Rajesh @ Marry, filing of explanation by IO/Inspector S. K. Gupta and further PE on 07.01.2025.
