Accused Pankaj is PO.

Accused persons namely Divesh @ Deepu, Deepak Kumar @ Arav & Deepak Kumar @ Bhuri @ Chira are absent.

Accused persons namely Virender Kumar @ Bunty and Afzal are present on bail.

Accused Rajesh @ Marry is present on interim bail (although on bail in present case).

Sh. Praveen Kumar Singh, Ld. Counsel for all accused persons except accused Rajesh @ Marry.

Ms. Priya Kakran, Ld. Counsel for accused Rajesh @ Marry.

Matter is fixed for PE.

Bailable warrants were issued against PW Ms. Geeta. Report has been received that PW Ms. Geeta is not traceable.

Ld. Addl. PP for the State submits that on the last date of hearing summons were served upon PW Ms. Geeta and her mobile phone number is also available on record which is 'Mob. No. 8178442755' and hence bailable warrants may be issued against her through DCP.

At request, issue bailable warrants in sum of Rs. 5,000/- against PW Ms. Geeta, through DCP, North, for next date of hearing.

PW Sh. Faizal Saifi has appeared before this court in pursuance of bailable warrants issued against him. He has tendered his unconditional apology. Same is accepted and he is warned to be careful in future.

Ld. Counsel for accused persons namely Divesh @ Deepu, Deepak Kumar @ Arav & Deepak Kumar @ Bhuri @ Chira submits that he is not in contact with abovesaid accused persons. Accused persons have not appeared before this court despite repeated calls since morning.

In view of submissions and circumstances, issue NBWs against accused persons namely **Divesh @ Deepu, Deepak Kumar @ Arav & Deepak Kumar @ Bhuri @ Chira** along with notice under Sec. 491 BNSS to their sureties, for next date of hearing.

Since three of the accused persons are absent today, recording of evidence is not possible. Accordingly, PW-10 Retd. SI Kalu Ram, PW-11 HC Satender & Sh. Faizal Saifi are discharged unexamined.

Put up for filing of report with respect to execution of NBWs against accused persons namely Divesh @ Deepu, Deepak Kumar @ Arav & Deepak Kumar @ Bhuri @ Chira, appearance of their sureties and further proceedings on 21.07.2025.
