before this Court in pursuance of NBWs issued
against him.**

Accused persons namely Rajesh @ Marry, Virender
Kumar @ Bunty, Divesh @ Deepu, Deepak Kumar
@ Bhuri @ Chira, and Afzal are present on bail.
None for all accused persons.

Matter is fixed for PE.

Accused Deepak Kumar @ Arav has filed an
application for cancellation of NBWs. On the perusal of record,
it is revealed that on 02.07.2025, NBWs were issued against
accused Deepak Kumar @ Arav which could not executed as he
was not found residing at the given address. Moreover, he had
not appeared before this Court again on 21.07.2025 and an
exemption application was dismissed as his surety also failed to
appear before this Court on that day and again NBWs were
issued against him through DCP, North. Today, report has been
received from the Office of DCP, North. As per the report,
accused Deepak @ Arav was not found at the given address and
he could not be traced. Since, the police has failed to trace the
accused again as he was not found residing at the address
provided by him and his surety also did not appear before this
Court also, this Court of considered opinion that the presence of

accused cannot be secured during the trial until he has taken into custody.

Accordingly, accused Deepak @ Arav is taken into custody and his application for cancellation of NBWs and recalling order dated 21.07.2025 is hereby dismissed.

Surety for accused Deepak @ Arav namely Sh. Narender Kumar submits that he needs some time to deposit the forfeited surety bond amount. Request is hereby allowed.

Surety Sh. Narender Kumar is directed to deposit surety bond amount in sum of Rs. 25,000/- on next date of hearing.

Accused persons namely Divesh @ Deepu and Deepak Kumar @ Bhuri @ Chira have deposited cost in sum of Rs. 5,000/-. Receipt has been issued to him in this regard.

Accused persons submits that their counsel cannot appear before this Court due to ongoing strike.

Accordingly, PW-10 Retd ASI Kalu Singh, PW-11 HC Satender Singh, PW- Smt Geeta and PW- Faizal are discharged unexamined.

Put up for deposit of forfeited surety bond amount and further PE on **06.11.2025**.
