Counsel for Kehkashan accused has filed
application for exemption from personal appearance of accused
Kehkashan with certificate dated 25.5.2017. For the reasons
given in the application, personal appearance of Kehkashan
accused is exempted for today only.

HC Gianender from Police Station Sarai Rohilla is
present and he submits that SI Sanjay Kaushik of the same
police station has informed him that report has not yet been
prepared by FSL in respect of CCTV footage.

Copies of the CD containing CCTV footage are to be

supplied to the accused persons. Matter was adjourned from 22.5.2017. Docket be issued to the Director, FSL to depute the expert assigned with the job and explain the delay in analysis, particularly when three accused are in JC in this case. Director also to ensure submission of report before next date so that its copies & copy of CD may be supplied to each accused.

HC Gianender is directed to inform SI Sanjay Kaushik to appear before this court on 10.7.2017 to explain non-appearance today.

As regards the bail application No.116/17 filed on behalf of Sahadat Hussain accused, Ld. Counsel submits that this application be dismissed as not pressed for the present and that accused shall file fresh bail application on supply of copy of CD or CCTV footage. I order accordingly.
