**ORDER
(Delivered on 21-11-2018)**

Accused/applicants have sought pre-arrest bail concession stating that complainant Sapna w/o applicant No. 1 Amit Jolly d/o Ram Bhatia r/o Umarpura, Tehsil Batala District Gurdaspur has filed false and frivolous application to S.S.P and same has been marked to Incharge

Women Cell, Batala and Incharge of Women Cell openly said that due to political pressure, she will make report against accused/applicants. So there is apprehension to accused/applicants that they will be arrested and falsely involved in criminal case without any fault of accused/applicants. Accused/applicants never raised any kind of demand of dowry at any point of time nor they have maltreated or harassed complainant. There is strong apprehension that accused/applicants will be arrested by police of P.S. Civil Lines, Batala. Accused/applicants are ready to join investigation as and when required by investigating agency.

2. Pursuant to notice Shri H. S. Bajwa, learned Additional Public Prosecutor along with ASI Rajinder Singh No. 2569/Btl P.S. Women Cell, Batala has put in appearance.

3. ASI Rajinder Singh has made a statement in court that inquiry is still pending against accused/applicants Amit Jolly and others in P.S. Women Cell, Batala. Their custodial interrogation is not required as yet. Consequently, application in hand renders infructuous and is dismissed with rider that in case subsequently any case is registered against accused/ applicants on basis of aforesaid inquiry, they will be given three days' notice prior to their arrest. This order will ensue for two months from today.
