Examination-in-chief.

On 07-06-2022 I was posted as Deputy Director (Chemistry Division) in Tripura State, Forensic Science Laboratory, Agartala.

On that date our office received one sealed packet from the Sub-Divisional Police Officer Dharmanagar, North Tripura vide forwarding memo No. 2513, Date: 26-05-2022 in c/w Churaibari PS Case No.: 2022 CRB 022, Date: 19-05-22 U/S: 20(C)/29 of NDPS Act, 1985 through special messenger: C/14852 Subrata Saha of Churaibari P.S.

The mode on which the parcel was found to be packed and the description of the seal on receipt. One yellow paper envelope sealed with 05 wax seals with impression SDPO DMN NORTH TRIPURA, seal impression matches with that of the forwarded specimen seal. On the packet. written case reference. DR No, address of addressee that of the forwarding authority along with

seal & signature of the forwarding authority. It was marked in this laboratory as CHEM/266/22.

Description of exhibits: Inside the sealed packet found 01 yellow paper envelope with 07 court wax seals bearing impression CJM DMN TPA(N). On the envelope affixed a piece of white paper on which written representative sample A3(1), A7(1) & A10(1), case reference, along with sample drawing certificate by SI Binode Behari Debbarma & JM 1" eclass. Dharmanagar (N). Tripura, subsequently marked in this laboratory as CHEM/266/22/A3(1), A7(1) & A10(1)).

Inside it found 03 heat sealed transparent poly packets each containing some greenish brown coloured plant materials with fruiting/flowering tops, seeds, etc. Weight in gm (w/o any packing materials)- 38.0, 35.5 & 32.2 respectively.

The period of examination was from 05-07-2022 to 12-07-2022.

Results of Chemical Examination :- The exhibits were analyzed by colour test, chromatographic method (TLC), macroscopic & microscopic methods.

CHEM/266/22/A3(1), A7(1) & A10(1)) Positive for the presence of ganja (Cannabis).

The remnants of the exhibits were returned separately under sealed cover.

On 27-11-2018 I prepared the report No. in two sheets of paper and put my signature with official seal and the specimen seal of SFSL, Tripura. This is my report which is marked as **Exhibit- 7 (as a whole)** upon identification by the witness.

Examination-in-chief.

On 20-05-2022 I was posted as DSP (DIB) of North Tripura, Dharmanagar and by virtue of that post I was also in charge of the District NDPS godown. On that date SI, Binod Behari Debbarma of Churaibari PS brought 130 kg of dry ganja in the godown in c/w case no. 22 of 2022 for storage. I received the contrabands and kept them in the godown in reference to entry no. 271 (30 / 2022). I also issued a godown receipt. Witness had identified the receipt and his signature on it and these are marked as Exhibit- 8 (as a whole).

Cross-examination

There is no facsimile of the seal in the godown receipt. In the receipt I also did not mention the exact quantity of ganja in each of the 12 nos of bundles.
