ORDER

The accused has pleaded guilty. I have explained him in vernacular language the consequences for pleading guilty. I am satisfied that accused has voluntarily pleaded guilty. The accused is heard on point of sentence. The accused submitted that he is poor and undertakes that he would not commit similar type of offence. The accused submitted that it is his first offence hence lenient view be taken by court and prayed to impose minimum fine. I am convinced that looking into the age of accused and his status in the society which he belongs minimum fine would meet the ends of justice. In the result, I am inclined to pass following order.

ORDER

Accused is convicted vide section 252 of the Code of Criminal Procedure for the offence punishable under section 283 of Indian Penal Code, 1860, and is sentenced to pay fine of **Rs. 200/- (Two Hundred Rupees only)** in default of payment of fine to suffer simple imprisonment for a period of 3 days.
