ORDER

The accused has pleaded guilty. I have explained him in vernacular language the consequences for pleading guilty. I am satisfied that accused has voluntarily pleaded guilty. The accused submitted that it is his first offence hence lenient view be taken by court and prayed to impose minimum fine. ORDER

Accused is convicted vide section 252 of the Code of Criminal Procedure for the offence punishable under section 283 of Indian Penal Code, 1860, and is sentenced to pay fine of **Rs. 150/- (One Hundred Fifty Rupees only)** in default of payment of fine to suffer simple imprisonment for a period of 3 days.
