ORDER BELOW EXHIBIT - 4

(1) This is an application by applicants/accused No.4 Ajaynath Kedarnath Sharma and accused No.5 Ms. Nisha Ajaynath Sharma seeking permission to travel abroad.

(2) Ld. APP has filed her say overleaf the application and resisted the same.

(3) Heard Ld. Advocate for applicant/accused and Ld. APP.

(4) Before this also the applicants/accused No.4 and 5 have traveled abroad with permission of this Court and had deposited Rs.1 Lakh each in the Court. Now, the applicants/accused again want to travel abroad i.e. to Dubai and Saudi Arabia during the period between 21.01.2026 to 05.02.2026 and from 08.03.2026 to 28.03.2026 and to Germany and Europe from 05.04.2026 to 20.04.2026. The applicants are businessmen and they are having business in India and abroad. There is no possibility of their absconding. Thus, they can be allowed to travel abroad during aforesaid period on same security deposit of Rs. 1 Lakh each deposited in the court vide receipt Nos.0199864 and 0199865 dated 12.03.2025 on usual terms and conditions. Hence, the order.

ORDER

1. Application (Exhibit-4) is allowed.
2. The applicants/accused No.4 Ajaynath Kedarnath Sharma and accused No.5 Ms. Nisha Ajaynath Sharma are hereby permitted to travel abroad to Dubai and Saudi Arabia during the period between 21.01.2026 to

05.02.2026 and from 08.03.2026 to 28.03.2026 to Dubai and from 05.04.2026 to 20.04.2026 to Germany and Europe on the following conditions -

(i) They shall provide travel itinerary alongwith place of residence and contact numbers to the IO before travel.

(ii) They are allowed to travel abroad during aforesaid period on the same security deposits of Rs.1,00,000/- each, deposited in the Court vide receipt Nos.0199864 and 0199865 dated 12.3.2025.

(iii) On returning India, the applicants shall mark their presence before the Ld. Trial Court on given date and I.O./ In charge of Kherwadi police station, Mumbai.
