Vide this order, this Court shall dispose off two separate applications seeking release of applicant/accused Siddharth @ Sidhu on Personal Bond filed in the afore-mentioned FIR cases.

Reply / verification of address of applicant/accused Siddharth @ Sidhu to the afore-mentioned has been received from IO concerned wherein he has mentions that the address of applicant/accused is found to be correct and his family is residing at the given address. Same be taken on record.

Ld. Counsel for applicant/accused Siddharth @ Sidhu submits that the applicant/accused Siddharth @ Sidhu has been granted bail in both above-mentioned FIR cases vide separate orders dated 06.06.2024 and 26.07.2024, however, applicant/accused Siddharth @ Sidhu has not been able to furnish fresh surety bonds till date.

It is further submitted that the applicant/accused Siddharth @ Sidhu belongs to a poor family due to which application/accused Siddharth @ Sidhu is unable to arrange the said surety. It is therefore, prayed that the present application may kindly be allowed.

Submissions heard. Record perused.

Perusal of the record shows that applicant/accused Siddharth @ Sidhu has been granted bail by this Court in both aforementioned FIR cases vide separate orders dated 06.06.2024 and 26.07.2024, however, he has not been able to furnish surety due to his poor financial condition. In view of the above, the present application for releasing applicant/accused Siddharth @ Sidhu is hereby allowed, subject to furnishing of Personal Bond for a sum of Rs.20,000/- before Jail Superintendent concerned. Accused/applicant Siddharth @ Sidhu be released from Custody if he is not required in any other case.

Copy of this Order be sent to the Jail Superintendent, Central Tihar Jail, Delhi.

Applications are disposed off accordingly.
