Accused Nilesch @ Kale is not present despite repeated calls. Further, It has been brought to the notice of this Court that *Ahlmad* of the Court of Ld. Predecessor Judge has not issuedailable warrants in the present case despite directions of the Ld. Predecessor Judge.

Issue show cause notice to *Ahlmad* of the Court of Ld. Predecessor Judge to explain the reason for non-compliance of the order of the Ld. Predecessor Judge.

Further, as per the accused, he has no means to engage the services of a private counsel. Accordingly, the accused has requested for engagement of a Ld.
