Notably, it is seen from the record that accused Nilesh @ Kale has not been entering appearance since 26.08.2025. Needless to mention that the said accused was not present even on 21.11.2025, 16.12.2025 and even today. Accordingly, **issue non-bailable warrants against the accused, namely, Nilesh @ Kale and notice under Section 446 Cr.P.C./Section 491 BNSS against his surety** for the next date of hearing.

Issue notice to the concerned IO to be physically present before this Court on the next date of hearing.
