Needless to mention, Mr. Amit Bhardwaj, *Ahlmad* of the concerned Court is not present despite directions.

At request of Mr. Sunil Kumar, Asst. *Ahlmad* in the Court of Ld., JMFC-07, Central, Tis Hazari Courts, Delhi, the matter is passed-over.

TCR has not been received despite pass-over.

Further, at this stage, the *Ahlmad* of the concerned Court has not entered appearance. Needless to mention, no reply to show cause notice, in terms of last order, is forthcoming either from *Ahlmad* or the Asst. *Ahlmad* from the concerned Court.

At this stage, Mr. Sunil Kumar, Asst. *Ahlmad* has submitted that as per the records of the concerned Court, post 31.05.2022, there has been no entry of the records of the present case/TCR in the concerned Court.

Notably, it is seen from the record, the TCR was never received by this Court despite repeated requisitions. Pertinently, as early as on 20.12.2023, this Court had issued notice to *Ahlmad* and Asst. *Ahlmad* of the concerned Court to trace the trial court record, however, on repeated occasions, TCR of the file, not pertaining to the present case was sent to this Court.

It is further reflected in the records of this Court that this Court had afforded numerous opportunities to *Ahlmad* and Asst. *Ahlmad* of the concerned Court to make endeavours to trace out the records so that the hearing in the present revision may commence. However, no response is forthcoming either from the *Ahlmad* or the Asst. *Ahlmad*. Needless to mention that the trial court record is not forthcoming despite the matter being pending adjudication as early as September, 2022. Ld. Counsel for the parties have repeatedly protested that the non-receipt of trial court by this Court has delayed the adjudication in the present case. As per the Ld. Counsel, they have also made

numerous endeavors to trace the trial court records, however, to no avail.

Accordingly, **a copy of this order be marked to Ld. Principal District & Session Judge (Headquarters)** to look into the conduct of *Ahlmad* and Asst. *Ahlmad* of the concerned Court.

Further, **issue notice to *Ahlmad* and Asst. *Ahlmad* of the concerned Court** to trace the file of the present case and place the same before this Court within a period of seven days from today.
