The applicant moved this application vide Section 482 of Bharatiya Nagarik Suraksha Sanhita, 2023 to enlarge him on bail in the event of arrest.

2. The investigating officer has filed its reply as per Exh.08 that applicant was called for inquiry in respect of the complaint filed against him, but he did not remain present for inquiry. The crime is not registered against present applicant. The grievance was of civil nature, hence the complaint is filed.

3. The application for pre-arrest bail is filed on 09.09.2024 and the said report of police station is dated 05.10.2024. As on date, the crime is not registered and the complaint moved before police station is disposed of.

4. In the light of submission, this application for pre-arrest bail needs to be disposed of. The order of 72 hours notice cannot be passed in the light of directions of Hon'ble Apex Court
