ORDER BELOW EXH. 05
IN CRIMINAL BAIL APPLN.NO.716/2024
PANVEL TALUKA POLICE STATION
PRAKASH HARI PATIL Vs. THE STATE OF MAHARASHTRA.
(PASSED ON 10th DAY OF SEPTEMBER, 2024)

1. The applicant moved this application for interim protection to extend him on bail in the event of arrest.
2. Pursuant to the observation of Hon'ble Bombay High Court, Bench at Goa in the case of **Chougule and Company Pvt.Ltd. V/s. The Public Prosecutor, State of Goa** vide Criminal Writ Petition No.618 of 2024 dated 02.08.2024, the hearing on interim bail application is conducted.
3. Heard learned advocate for applicant. Perused FIR and documents.
4. The crime is not yet registered. The crime is likely to be registered for the offence under Section 420, 34 of the Indian Penal Code on account of complaint moved by the complainant at Panvel Taluka police station. He has apprehension of his arrest at

the hands of police. The transaction is relating to outstanding dues. The applicant has placed on record the bank statement that he has repaid the amount.

5. In the light of submission on behalf of learned advocate of applicant coupled with reasons foregoing, at the same time opportunity ought to be given to prosecution to file reply and meantime, it is justified to grant interim protection to applicant in the event of his arrest. With this, I pass following order;

ORDER

1.	The application for interim protection in the event of arrest on behalf of applicant is allowed till next date.
2.	The applicant be released on bail on furnishing P.R. and S.B. of Rs.50,000/- (Rs. Fifty Thousand) with one surety in the like amount.
3.	The applicant shall attend the concerned police station on every second Saturday of the month in between 11.00 a.m to 2.00 p.m till next date.
4.	The applicant shall assist to Investigating Officer whenever called under written intimation.
5.	Issue notice to respondent and informant returnable on 24.09.2024.

6.	Inform to concerned Police Station accordingly.
