The above named applicant begs to present this revision against the Judgement and order of Judicial Magistrate First Class, Gadhinglaj in Summary Cri. Case No. **52/2017** dated **03/10/2022** and prays that this Hon'ble Court may be pleased to alter the order of conviction of the accused and enhance the sentence of imprisonment.

GROUND

1. That, the revision applicant is proved his case in the Lower Court behind reasonable doubt.
2. That after the considering all the documentary and oral evidence of the complaint the Lower Court convicted to the accused and passed the following order :-

ORDER

1. *Accused **Drakshyani Kuber Magdum**, is hereby held guilty and convicted vide Section 255(2) of Criminal Procedure Code for an offence punishable under Section 138 of the Negotiable Instruments Act and sentenced to suffer Simple imprisonment for **three (03) months**.*
2. *In addition, accused **Drakshyani Kuber Magdum**, to pay Rs. **2,92,500** (Rs. Two Lac Ninety Two Thousand and Five Hundred only) as a compensation to the complainant vide Section 357(3) of Criminal Procedure code within **three (03) month**, in default to suffer further Simple Imprisonment for a period of **one (01) month**.*
3. *Sentence of imprisonment in this case and in SCC No. 49/2017 shall run concurrently.*

4. *Sentence of imprisonment in this case and in SCC No. 49/2017, SCC No. 52/2017 and SCC No. 54/2017 shall run concurrently.*
 5. *Judgement pronounced in the absence of accused. Issue conviction warrant.*
 6. *Accused to surrender her bail bonds.*
 7. *Copy of the judgment shall be given to the accused forthwith, free of cost.*
3. That, the Lower Court has passed the sentence of imprisonment for three months which is not adequate. The Lower Court has not considered the main object of legislature while imposing the inadequate sentence.
 4. That, there is no any strong reasons or evidence to take lenient view against the accused while imposing inadequate sentence.
 5. That, the question of leniency while imposing the sentence is not a matter in desecration under the N. I. Act.
 6. That, the order of Trial Court to imposing the minimum sentence without any legal reason is resulting the violation of fundamental principle and main object of N.I. Act.
 7. That, the Hon'ble Court undoubtedly has jurisdiction to enhance the sentence under the revisional power given in the Criminal Procedure Code.
 8. That, the Lower Court pronounced his Judgement on **03/10/2022**. An application for a certified copy of the

Judgment was made on **04/10/2022** and copy received on **17/10/2022**. Therefore after the deduction of the above said period the revision is within limitation.

9. **It is therefore prayed that,** your honour may be pleased to kindly allow this criminal revision and alter the order of Lower Court and may impose the sentence up to maximum limit prescribed by the N. I. Act and oblige.
