J U D G M E N T

1. Accused person namely **1.Ataul Ansar and 2.Vijay Mahto** is facing trial in this case for the offence **under section 392 of IPC**.
2. The brief facts of the case is that on 19-09-2022 above named accused persons snatched mobile of the informant wife. Hence this case was filed **under section 392 of IPC** on dated **19-09-2022** against the accused namely **1.Ataul Ansar and 2.Vijay Mahto**.
3. In this case cognizance was taken **03-11-2022 under section 392 of IPC** against the accused namely **1.Ataul Ansar and 2.Vijay Mahto**.
4. On, charges were framed **under section 392 of IPC** against the accused namely **1.Ataul Ansar and 2.Vijay Mahto** and the same was read over and explained in Hindi to him to which he pleaded not guilty and claimed to be tried. Hence this trial.
5. On **06-05-2025**, the statement u/s 313 of Cr.P.C. of the accused person was recorded.
6. Now the matter is to decide that whether the prosecution has proved it's case beyond all reasonable doubts against the accused persons or not?

F I N D I N G S

7. During trial the prosecution has not examined any witnesses. This is case of no evidence.

8. Ld. defence counsel of the accused person has argued that accused person has been falsely implicated in this case. He has not committed any offence. Prosecution has not examined any witness.
9. After having above discussion, the prosecution witnesses, it will be expedient to analyse the charges were framed against the accused persons in the light of evidence and the argument advanced by both the parties. To prove the charges were framed **under section 392 of IPC** the prosecution has not examined any witnesses in this case. Thus, on the above discussion, it is clear that prosecution has not been able to prove his case beyond shadow of all reasonable doubts. This case is no evidence.

Thus, the accused person namely **1.Ataul Ansar and 2.Vijay Mahto** is entitled to be acquitted. The above named accused person is hereby acquitted from the charges against them **under section 392 of IPC**.

10. The accused person namely **1.Ataul Ansar and 2.Vijay Mahto** with his bailors are also discharged from their respective liability of the bail bonds.
