During hearing, accused submits that she wants to settle the civil liability in all the cases i.e. in the present matter alongwith other connected cases (total 42 cases / inspections including Misc application in respect to the CC No. 950/22 (in which accused had been declared PO on 31.05.2023 and today Ld. Counsel for accused filed separate application for cancellation of PO proceedings which is listed for today itself fixed for hearing), CC No. 422/22, CC No. 929/23, CC No.959/23, CC No.308/25, CC No.921/24) with the complainant company under Multiple Case Scheme for a total sum of Rs. 2,78,000/- out of which Rs.78,000/- has already been paid and today remaining settled amount of Rs.2 lacs in Ct. case no. 422/22 has been paid to the AR for the complainant company. Further, the accused also shows her willingness for pleading guilty in the above noted case as well.

AR for the complainant submits that accused has paid

entire settlement amount and civil liability has been settled.

It is submitted by the accused that she want to plead guilty with further submission to take lenient view against her.

Accused is duly warned about the legal consequences of her plea of guilt and she has been informed that she may be convicted on the basis of her plea of guilt. She has been given time to think over again and to consult her counsel but she has insisted to plead guilty to the offence committed by her.

After making necessary enquiry from the accused, the court is satisfied that the accused has voluntarily pleaded guilty to the offence committed by her.

It is prayed by accused that benefit of Probation Act be given to her and she be released on probation.

Separate statement of AR for the complainant regarding civil liability is recorded.

Separate statement of accused regarding plea of guilt towards criminal liability is also recorded.

So far as, criminal liability is concerned the accused has already been pleaded guilty as per the statement made today, hence, accused is held guilty for the offence u/s 135 of electricity Act.

Let notice be issued to the SHO concerned for filing report regarding previous conviction/ involvement report of the accused and report from the concerned Probation officer be also called for the next date of hearing.

List the matter for filing report as well as order on the point of sentence on **15.07.2026 with connected cases.**
