**This is an application, seeking cancellation of bailable warrants, issued against the accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj.**

Mr. Gaurav Nagar, Ld. Counsel for accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj.

Accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj are present.

Present application has been moved on behalf of the accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj, seeking cancellation of bailable warrants, issued against the said accused persons today *i.e.* on 04.06.2026 along with fresh *vakalatnama*.

Issue notice of the present application to the State. Ld. Addl. PP accepts notice on behalf of the State. Copy of the present application has been supplied to Ld. Addl. PP for the State.

It is stated in the application that the said accused persons could not appear before this Court during the earlier call as they were travelling to Delhi from Chandigarh and were stuck in traffic jam. Accordingly, it is submitted by the Ld. Counsel that the reasons for non-appearance of the accused persons were neither deliberate nor intentional and that it was solely due to inadvertence that he could not appear before this Court on today *i.e.* on 04.06.2026 during the earlier call. Therefore, it is prayed that the bailable warrants may be recalled.

*Per contra*, Ld. Addl. PP for the State has vehemently opposed the present application on the ground that the applicant has deliberately failed to appear before this Court on the last occasion.

Arguments heard. Record perused.

For the reasons so stated in the application and considering the submissions addressed before this Court, this Court deems it prudent to recall the bailable warrants issued against the accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj.

Accordingly, directions for issuance of **bailable warrants against the accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj** are hereby **recalled** subject to the said accused persons depositing a fine of Rs.500/- each with DLSA, Central, Tis Hazari Courts, Delhi. The accused persons are warned to be careful in future.

Further, the accused persons are apprised of today's order and next date of hearing, *i.e.*, on **11.08.2026**.

A copy of this order be given *dasti* to Ld. Counsel for the accused persons.

At this stage, accused persons, namely, Shashi Bhushan Bhardwaj and Ritu Bhardwaj have filed a consolidated proof of deposit of cost of Rs.500/- with DLSA, Central, Tis Hazari Courts, Delhi. Same is taken on record.
