

Special Case No.128/2024**Exh.12****DEPOSITION OF WITNESS NO.01 FOR THE PROSECUTION**

Examination-in-chief by Ld. A.P.P. Shri. G. K. Musale for State :-

1. At the time of incidence, I along with my wife and children reside in the house. The Accused are my neighbourer. They are having the business of preparing the statutes of gods. I am acquainted with them. On 29.03.2024 at about 02:00 p.m. I was in my house. My children are in a habit of giving food and water to the birds. My daughter Varsha have gave rise to give the birds i.e. sparrow. She gave rise for the feeding in front of my house. The Accused has seen such fact. The Accused thereby used abusive words against us. The Accused called Manoj Shinde and asked to him to came at the spot. That time Accused No.1 to 3 and child in-conflict with law and other two unknown person were came at the spot. The Accused entered in my house forcibly and assaulted us. They caught hold my daughters and assaulted them. They sit on my wife and snatched the mangalsutra wear by her. They also outraged the modesty of my wife and daughters. The Accused are also armed with iron rod, stick and scythe. They also threaten us to kill and further defame us based on the caste. We have not respond them. If we response, they might have killed us. After the incidence, we visited the Kotwali Police Station, Ahmednagar. They have not lodged our

complaint. We visited the Superintendent of Police office, requested the Superintendent of Police. Thereafter my complaint is registered. Copy of F.I.R. shown to me, bears my signature. Contents are true and correct. It is at **Exh.13**. I can identify the Accused if shown to me. Today, Accused Omkar and harshada are present. I can identify the absent Accused if shown to me.

2. Accused defame us by saying “तुम्ही चमटे आहे का, धेडगे आहे का, इतके घाण कसे राहाता”. My supplementary statement recorded by the police. I am belongs to Hindu Mochi caste. I do not know the caste of the Accused. The persons present at the spot as well as Accused stated that, “आम्ही मराठा समाजाचे आहोत, आम्ही ५२ कुळी १०० कुळी असे आहोत.” Accused spread terror in our mind. Accused also threaten us that they will not reside us in that place.

Cross-Examination by Ld. Adv. Shri. Zinjurde for Accused :-

3. Since last 04 to 05 years, I reside at Shivaji Nagar. In that colony, approximately 50 to 60 houses and some shops are present. It is true to say that, Accused have no house at Vyankatesh Colony. Witness volunteer that Accused has a shop in the Vyankatesh Colony. It is true to say that, Accused prepared the statutes of gods in that shop. It is not true to say that, Accused used to keep the statutes of gods in the shop as well as in front of shop. We are veg as well as non-veg by food. One open space is in existence in between the shop and the house. My daughter are keep the food as well as water for the birds in that open space. It is not true to say that, we also keep the remaining cooked food for the birds in that open space. **Portion mark A** in the F.I.R. is read over to me. It is true and correct. It is not true to say that, my daughter as well as my wife used to throw the

sewerage water in that open space. It is not true to say that, because we are throwing the sewerage water, Accused used to say us that not to throw such water, because due to that there is defame the statue of gods. It is not true to say that, because of that, we got annoyed. It is not true to say that, we assaulted the Accused Harshali and Omkar. It is true to say that, at that time, we have recorded the incidence in mobile phone. We have handed over the video shooting recorded by us to the police. On 29.03.2024 at about 04:45 p.m., Accused lodged one complaint against us at Kotwali Police Station, Ahmednagar. It has NCR No.335/2024.

4. It is not true to say that, I have not depose before the police that, Accused forcibly entered in my house, sit on my wife and snatched her mangalsutra forcibly. I cannot assign any reason why the said portion not appeared in the F.I.R. I have stated before the police that Accused armed with stick, iron rod and scythe, assaulted us and further defame us based on caste. I cannot assign any reason why the said portion not appeared in the F.I.R. I have stated before the police that, as Kotwali Police Station, Ahmednagar not recorded my F.I.R., I visited Superintendent of Police office and thereafter my complaint is registered by Kotwali Police Station, Ahmednagar. I cannot assign any reason why the said portion not appeared in the F.I.R. After recording my F.I.R., police again inquired with me. They prepared the spot panchanama. It is true to say that, the incidence of scuffle took place in our house is at first floor. It is not true to say that, on the day of incidence, we have used abusive words against the Accused and further assaulted them. It is not true to say that, false F.I.R. lodged against them. Unknown person have used abusive words against as “आम्ही मराठा समाजाचे आहोत, आम्ही ५२ कुळी १०० कुळी

असे आहेत”. It is not true to say that, Accused have not defame us on our caste. It is not true to say that, Accused never outraged the modesty of my daughter and wife. It is not true to say that, we have assaulted the Accused and further lodged false F.I.R. against them. It is not true to say that, as we have anger against the Accused, today I am deposing falsely against them.
