Issue notice to the concerned Medical Officer In-charge, Jail No.1, Tihar, New Delhi to join the proceedings through V.C. on the next date of hearing for the purpose of clarifications.

At request of counsel for the accused, the aforesaid interim bail application of the accused be put up for consideration on **19/01/2022 at 12:00 Noon**. Date of 19/01/2022 is given at the specific request and convenience of counsel for the accused.

Meanwhile, Jail Authorities are directed to provide the requisite/ necessary/ immediate medical treatment to the accused, as per his medical condition on priority basis. Jail Authorities are also directed to get the accused admitted in the Hospital inside the jail or outside the jail referral/ Govt. Hospitals on priority basis, if required, as per rules. In case, surgery of the accused is required/ planned, the Jail Authorities are directed to make necessary arrangements for the same on priority basis. Jail Authorities are also directed to provide appropriate/ requisite diet to the accused as per his medical condition.

Copy of this order be sent to the concerned Jail Superintendent and Medical Officer In-charge for information and compliance.
