Reply/ report not received from the Superintendent and Medical Officer In-charge, Central Jail No.3, Tihar, New Delhi.

Reply/ report of Dr. Prashant Lakhe is received to the E-mail of this Court.

It is submitted by Dr. Prashant Lakhe that the accused was examined on 07/05/2022 and he has prescribed medical tests of the accused Swapnil and accused is to be reviewed in the OPD on coming Thursday i.e. 12/05/2022.

Dr. Prashant Lakhe is directed to file further/ detailed report regarding medical condition and treatment of accused Swapnil alongwith all medical records positively on or before the next date of hearing.

It is submitted by counsel for the accused that as per medical advice, accused required physiotherapy two times in a day but the accused still has not been provided physiotherapy on regular basis and medical condition of the accused is deteriorating day-by-day and left side power is also decreasing and aforesaid report is not complete and further/ appropriate report in this regard be called from Dr. Prashant Lakhe, Jail Authorities and Medical Officer In-charge.

Issue fresh notice to the concerned Jail Superintendent and Medical Officer In-

charge with direction to file appropriate report regarding medical condition, treatment of the accused and schedule of physiotherapy given to the accused and also directed to file appropriate report as to whether regular physiotherapy has been given to the accused or not, on or before the next date of hearing. They are also directed to file as to how many times in a day physiotherapy of the accused is required/ advised and how many times in a day physiotherapy is given to the accused. They are also directed to file photocopies of latest prescription/ medical record of the accused on or before the next date of hearing.

At request of counsel for the accused, the aforesaid bail application of the accused be put up for consideration on **13/05/2022**. Date of 13/05/2022 is given at the specific request and convenience of counsel for the accused.

Meanwhile, Jail Authorities are directed to provide the requisite/ necessary/ immediate medical treatment to the accused, as per his medical condition on priority basis. Jail Authorities are also directed to give the physiotherapy to the accused on regular basis, if advised by the concerned Doctor. Jail Authorities are also directed to get the accused admitted in the Hospital inside the jail or outside the jail referral/ Govt. Hospitals on priority basis, if required, as per rules. In case, surgery of the accused is required/ planned, the Jail Authorities are directed to make necessary arrangements for the same on priority basis. Jail Authorities are also directed to provide appropriate/ requisite diet to the accused as per his medical condition.

The concerned Medical Superintendent, G.B. Pant Hospital, New Delhi is directed to expedite the medical tests of the accused Swapnil, if prescribed.

Copy of this order be sent to the concerned Jail Superintendent and Medical Officer In-charge, Dr. Prashant Lakhe, Neurosurgery Department, G.B. Pant Hospital, New Delhi and concerned Medical Superintendent, G.B. Pant Hospital, New Delhi for information and compliance.
