File taken up today on the bail application u/s. 439 Cr.P.C of the accused Swapnil for extension of interim bail for the period of three months.

Opinion of Medical Board alongwith letter of OPD Incharge, G.B.Pant Hospital is received.

As per report of Dr. Swapan Gupta, the Medical Board was constituted and the patient was examined on 11/10/2022 by Department of Neurology. It is mentioned in the opinion of Medical Board that *“The medical board examined the patient and is of the opinion that patient is having Paraplegia probably functional. Patient is advised to undergo detailed Psychiatric evaluation and investigation as under:- SSEP both UL/LL”*

Heard. Perused. Some clarifications are required in respect of aforesaid opinion of the Medical Board, G.B.Pant Hospital.

Issue notice to Dr. Swapan Gupta to join the proceedings through video conferencing, for the purpose of clarifications, on the next date of hearing i.e. **15/10/2022 at 12:30 PM.** Dr. Swapan Gupta is also directed to file appropriate report in respect of medical condition, treatment and future course of treatment of the accused Swapnil on or before the next date of hearing.

Vide order dated 05/08/2022 passed by this Court, interim bail for the period of one month was granted to the accused Swapnil and vide order dated 05/09/2022, interim bail of the accused was extended for the further period of one month and vide order dated

01/10/2022, interim bail of the accused was extended till 06/10/2022 and vide order dated 06/10/2022, interim bail of the accused was extended till today. Considering the facts, circumstances and submissions made, interim bail of the accused Swapnil is further extended till the next date of hearing i.e. 15/10/2022 subject to the same terms and conditions as imposed vide aforesaid interim bail orders of the accused Swapnil passed by this Court on 05/08/2022 and 05/09/2022.

SHO/ IO is directed to file appropriate report in respect of medical condition, treatment and future course of treatment and also directed to file appropriate report as to whether the accused Swapnil has misused the terms and conditions of the interim bail or not, on or before the next date of hearing.

At request of counsel for the accused, the aforesaid interim bail application of the accused be put up for consideration on **15/10/2022 at 12:30 PM.** Date of 15/10/2022 is given at specific request and convenience of counsel for the accused.

Copy of this order be sent to the Dr. Swapan Gupta, G. B. Pant Hospital, New Delhi and concerned Jail Superintendent for information and necessary action. Copy of order be also sent to the concerned SHO/IO for compliance. Copy of this order be given dasti to counsel for the accused, if prayed for.
