The matter is passed over as Farman, Vijay Kumar,
and Arpit have not been produced from judicial custody.

At this stage, IO Inspector Ichha Ram has submitted that fresh bailable warrants may be issued against PW Sadiq and he would endeavor to execute the same upon the said witness.

Accordingly, **issue bailable warrants in the sum of Rs. 5,000/- against PW Sadiq, to be executed through the IO Inspector Ichha Ram** returnable on the next date of hearing.

At this stage, Ld. Addl. PP for the State has submitted that the factum of filing of supplementary charge-sheet *qua* accused Akash @ Hanny, has already been brought to the notice of Hon'ble High Court of Delhi and the Hon'ble High Court *vide* order dated 27.05.2024 had directed the IO to file the same before the Hon'ble Court. Accordingly, Ld. Addl. PP for the State has submitted that the arguments on charge *qua* accused Akash @ Hanny may be heard subsequent to 07.10.2024, being the next date before the Hon'ble High Court.
