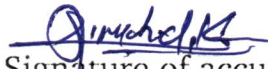

**JUDGMENT**

The accused is present. He voluntarily pleaded guilty by filing application. I have heard the accused. The accused is voluntarily pleading guilt. Hence, I accept the same. Heard the accused on the point of sentences. He prayed for leniency. Considering the nature of offences and submissions of the accused, I pass the following order.

**ORDER**

1. The accused is convicted of the offence punishable under Section 281 of the Bharatiya Nyaya Sanhita, 2023 vide section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and sentenced to pay a fine of Rs. 500/- (Rupees Five Hundred Only) in default the accused to suffer simple imprisonment of 07 (Seven) days.
2. The accused is also convicted of the offence punishable under Section 125 of the Bharatiya Nyaya Sanhita, 2023 vide section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and sentenced to pay a fine of Rs.1,000/- (Rupees One Thousand Only) in default the accused to suffer simple imprisonment of 10 (Ten) days.
3. Copy of the order be given free of cost to the accused.
