JUDGMENT

The accused No.1 to 4 have voluntarily pleaded guilty. Hence, their plea is accepted. As the accused have pleaded guilty, I found them guilty and convict them for the offence p/u/s. 188 of the Indian Penal Code.

Heard the accused on the point of sentence. They submitted that leniency be shown to them. While the Ld. APP submitted that maximum punishment be imposed. Considering all the facts and circumstances, I am of the opinion that the following order would meet the ends of justice.

ORDER

1] The accused No.1. Vivek Virendra Goyal, Age –40 years. R/o.- at - A-1, 1st Floor, New Hill View Apartment, Barve Nagar, Netaji Palkar Road, Ghatkopar (W), Mumba, accused No.2 Govind Indrachandra Sharma, Age – 59 years., R/o.- Flat No.201, Plot No.201, Sector-12, Navi Mumbai, accused No.3. Smt. Poonam Ravikant Poddar, Age – 44 years, R/o.- Neptune CHS, Millenium Paradise, Thakur Village, Kandivali (W), Mumbai – 101 and accused No.4. Smt. Sushila Rajeshvar Donka, Age – 49 years, R/o-. Flat No.5/29, Kashish Park, LBS Road, Block Sector, Thane Millenium, Thakur Village, Kandivali (W), Mumbai are convicted, vide Sec. 252 of the Cr. P. C., of the offence p/u/s.188 of the IPC and they are sentenced to pay fine of Rs.200/- each (Rs. Two Hundred only) each in default to suffer S. I. for a period of 7 (seven) days.

2] The accused to surrender to their bail bond.

3] Copy of this judgment and order be supplied to the accused free of cost.
