ORDER BELOW EXH. 02

(Passed on 17/11/2022)

1. In Crime No.151/2022 registered with Sonala Police station for the offence punishable under Sections of 353, 332, 294, 323, 336, 326, 504, 506 of I.P.C., the present application is filed for seeking regular bail. Earlier also his bail application was filed during his remand, it was rejected. Heard, learned Advocate for applicant/accused, perused the say of I.O. Heard learned APP for prosecution.

2. It is submitted on behalf of the applicant/accused that he is falsely involved in present crime. He is the only earning member of his family. He has not committed any such offence. On the date of incident when for Pola festival the public gathered along with their bullock, at that time the incident took place. There was dash to him so he was injured. The police were on Bandobast duty, they were assaulted and obstructed by him are the allegations made in FIR. As he is from poor family, he is falsely implicated in the same. Nothing is seized from him. His earlier bail application was rejected as it was the early stage of investigation. But now investigation is completed. Therefore, claims for his release on bail. It is argued that he has no involvement in the same and false evidences are collected to implicate him. As the investigation is over no purpose will be served by keeping this accused behind bars. Hence, prayed for releasing him on bail.

3. As per submissions of Ld. A.P.P. and I.O., the offences alleged to have been committed by this accused/applicant is about deterrence to public servant while he was discharging his duty. By strongly opposing the bail application for various reasons like tampering evidences, pressurize the witnesses and may commit again such serious offence, prosecution has resisted for bail and further submitted about registration of other offences against him since the year 2017 as he being the habitual offender. He may abscond and fail to attend the court if released on bail.

4. On considering the submissions and on perusal of charge-sheet, it is seen that the investigation is completed. Considering all the collected documents, evidence as per charge-sheet, nature and gravity of offence, involvement of accused, it will take its own time to conclude the trial. It will not be proper to keep him behind bar for unlimited period. Hence, the following order.

ORDER

1] Application is allowed.

2] Applicant/accused namely Ravindra @ Amol Gajanan Lonkar in Crime No.151/2022 registered with Police Station Sonala, is hereby released on bail on his executing PR bond of Rs.50,000/- (Rs. Fifty Thousand only) with one solvent surety in the like amount on conditions that:

[I] The applicant/accused shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the accusation against them so as to dissuade

them from disclosing such facts to the Court or to any Police Officer and not to pressurize any prosecution witness.

- [ii] The applicant/accused shall provide his permanent address proof, copy of Aadhar card and photographs.
- [iii] He should not involve himself in commission of alike offences.
