Cause of action : The Suit arose on 11.02.2016, When the defendants have obtained a loan, and jointly executed a demand promissory note and continuing security, On 29.06.2017, 08.02.2019 and 04.02.2022, when acknowledgment of debt and securities and subsequent dates at Pudukkottai town within the Jurisdiction of this Hon'ble court,

Court fee : Valuation of Suit: Rs.3,68,228/-

Pays a Court Fee of Rs.11,046/- Under Sec 22 of TNCF Act.

This suit came for final hearing before this court on 13.06.2023 in the presence of Thiru.V.Gunasekaran, Advocate for Plaintiff and Thiru. M. Suresh counsel for the defendants, and the defendants having been set exparte, and on perusal of available material records as well upon hearing the plaintiff and having stood over for consideration till this day, this court delivers the following:

Decree

1. The Suit is decreed with costs.
2. Thereby directing the defendants to repay personally, jointly and severally Rs.3,68,228/-to the plaintiff and the defendants are further directed to pay the interest at 12.70% per annum for the principal amount of Rs.3,57,000/- from the date of filing of suit till this date and thereafter at 6% per annum till the realization of the above said amount
3. and that the defendants to pay a sum of Rs.14,192/-being the cost of this suit to the plaintiff.
