ORDER

1. This application for regular bail has been filed by applicant/accused Harmanpreet Singh alias Luv in case FIR No.02 dated 02.01.2019 for the offence under section 379-B of Indian Penal Code, registered at Police Station Mohkampura.
2. On notice, Public Prosecutor opposed the bail application.
3. I have heard counsel for the applicant/accused and the Public prosecutor for the State and have gone through the record of the Trial Court.
4. As per allegations appearing on the record, on 2.1.2019 two

unidentified youngmen who were travelling on Aactiva snatched Samsung J-2 Mobile phone of complainant Pardeep Kumar near Verka chowk by pointing knife towards him and then the said miscreants sped away from there. Complainant reported about the said snatching to the police on the same day.

5. There are also allegations that after registration of FIR in this case, on the same very day i.e. 2.1.2019 applicant was apprehended by the police alongwith Scooter No.PB-02BS-8393 and at the time of his arrest, aforesaid Samsung Mobile Phone of complainant was recovered from his possession.

6. The applicant also got recovered one knife from the diggy of scooter No.PB-02BS-8393.

7. FIR in this case was registered against two unknown persons. The applicant is in custody since 2.1.2019 and presently is lodged in judicial custody. On completion of investigation, challan has already been presented in the Court of Illaqa Magistrate against the applicant. However, it will take time for conclusion of trial which is yet to begin. So no purpose will be served by detaining the applicant in custody for further period.

8. Thus, without commenting upon the merits of the case, this bail application is allowed and applicant is directed to be released on bail on his furnishing personal bond in the sum of Rs.50,000/- with one surety in the like amount, to the satisfaction of Illaqa/Duty Magistrate, subject to following terms and conditions:-

1) that applicant/accused shall not give any threat or inducement to any prosecution witnesses;

2) that applicant/accused shall not leave India without prior permission of the court.

Record of the trial court be returned alongwith copy of this order. File be consigned to record room.
