The case was called out for hearing on the surrender cum bail petition dated **12.08.2026** filed on behalf of the accused persons namely

Islam Ansari @ Md. Islam Ansari s/o Wakil Ansari

Esrail Ansari s/o Wakil Ansari

Ismail Ansari s/o Wakil Ansari

Md. Ijarayal Ansari s/o Wakil Ansari are taken in judicial custody.

On being called, learned counsel for both sides appeared before the Court. Learned counsel for the defence submitted that the accused persons are innocent. He has not filed any bail application either before this Court or before the Hon'ble High Court. It was further submitted that the accused persons except Islam Ansari @ Md. Islam Ansari s/o Wakil Ansari has no any criminal antecedents. It was also contended that there is no eyewitness to the alleged occurrence except informant. They are ready and willing to furnish adequate bail bonds. Also, this is matter of first appearance before the court and accused persons are law abiding citizen and promised to be present in person as per the direction of this court. Accordingly, it was prayed that they be enlarged on bail.

Learned P.O. for the state strongly opposed the bail application and submitted that the allegations levelled against the accused persons are of a serious nature and also Accused petitioner no.(1) Islam Ansari @ Md. Islam Ansari s/o Wakil Ansari has criminal antecedent of serious nature offence. It was, therefore, prayed that the bail application be rejected.

Heard learned counsel for both sides and perused the record. From the record, it appears that, due to the non-appearance of the accused before the Court, an order dated **13.05.2025** was passed directing issuance of NBW and further NBW issued against him by this court order dated **26.05.2026** of a Non-Bailable Warrant (NBW) against. After perusal of the record it transpires that all the 4 accused are the resident of the same place and they share nephew uncle relationship with the informant and the matter is related to petty quarrel for harvesting rice grain. Also Accused no.1 has been enlarged on bail in the previous criminal case.

Having regard to the facts and circumstances of the case, the accused persons are

Islam Ansari @ Md. Islam Ansari s/o Wakil Ansari

Esrail Ansari s/o Wakil Ansari

Ismail Ansari s/o Wakil Ansari

Md. Ijarayal Ansari s/o Wakil Ansari are directed to be released on bail upon furnishing a bail bond of Rs. 10,000/- (Rupees Ten Thousand only) with two sureties of the like amount, subject to the condition that the accused shall remain present in person before this Court on the next date fixed for hearing.
