ORDER

Today the matter is listed in Lok Adalat. The accused has pleaded guilty. I have explained him in vernacular language the consequences for pleading guilty. I am satisfied that accused has voluntarily pleaded guilty. The accused is heard on point of sentence. The accused submitted that he is poor and undertakes that he would not commit similar type of offence. The accused submitted that it is his first offence hence lenient view be taken by court and prayed to impose minimum fine. I am convinced that looking into the age of accused and his strata of society which he belongs minimum fine would meet the ends of justice. Hence I pass the following order.

ORDER

Accused is hereby convicted for the offence punishable under section 283 of Indian Penal Code, 1860 vide section 252 of Code of Criminal Procedure and is sentenced to pay fine of **Rs.200/- (Rs. Two Hundred only)** in default of payment of fine to suffer simple imprisonment for a period of 3 days.
