Ld. Counsel for the respondent submits that he has no objection if the present transfer petition is allowed and OMP (COMM.) No.37 of 2026, titled as 'M/s. Deepak & Co. Vs. Union of India' pending in the court of Sh. Sanjay Khanagwal, Ld. District Judge (Commercial Court)-02, PHC, NDD, is transferred to the court of Sh. Pulastya Pramachala, Ld. District Judge (Commercial Court)-01, PHC, NDD, where other two petitions U/s.34 of the Arbitration and Conciliation Act, 1996 are pending.

This petition has been filed for seeking transfer of OMP (COMM.) No.37 of 2026, titled as 'M/s. Deepak & Co. Vs. Union of India' from the court of Sh. Sanjay Khanagwal, Ld. District Judge (Commercial Court)-02, PHC, NDD, to the court of Sh. Pulastya Pramachala, Ld. District Judge (Commercial Court)-01, PHC, NDD, on the ground that total three petitions U/s.34 of the Arbitration and Conciliation Act, 1996 were filed against the Award. Out of these three petitions, two have been assigned to the court of Sh. Pulastya Pramachala, Ld. District Judge (Commercial Court)-01, PHC, NDD, being OMP (COMM.) Nos.

38 of 2026 and 39 of 2026 whereas, OMP (COMM.) No.37 of 2026 has been assigned to the court of Sh. Sanjay Khanagwal, Ld. District Judge (Commercial Court)-02, PHC, NDD.

All these three OMPs have arisen from the same Award, therefore, it would be in the interest of justice, if all the three petitions U/s.34 of the Arbitration and Conciliation Act, 1996 are assigned to the same court.

Considering the above facts and circumstances, petition filed U/s.24 read with Section 151 of CPC is allowed. OMP (COMM.) No. 37 of 2026 titled as 'M/s. Deepak & Co. Vs. Union of India' pending in the court of Sh. Sanjay Khanagwal, Ld. District Judge (Commercial Court)-02, PHC, NDD, is withdrawn from the said court and assigned to the court of Sh. Pulastya Pramachala, Ld. District Judge (Commercial Court)-01, PHC, NDD.

Both the parties are directed to appear before the court of Sh. Pulastya Pramachala, Ld. District Judge (Commercial Court)-01, PHC, NDD on **09.06.2026 at 02.00 pm**.

Ahlmad concerned is directed to send the files to the transferee court forthwith. Copy of this order be sent to the courts concerned.
