ORDER:

1. This order of mine shall dispose of first application for anticipatory bail under Section 482 of BNSS, 2023 moved by accused/applicant in case FIR No. 124 dated 13.09.2025 for offence under sections 351(2)/303(2)/324(5)/324(3)61(2) of BNS and U/s 27 of Arms Act, P.S. Vairoke.
2. Learned counsel for accused/applicant pressed for confirmation of anticipatory bail on the ground that accused/applicant has already joined the investigation in the above mentioned case as per interim bail order dated 03.10.2025 and prayed for confirmation of bail as his further custodial interrogation is not required to the police.

3. Learned Addl. PP for State opposed the bail application, though he fairly got recorded the statement of ASI Mukhtiar Singh, present in the court.

4. Perusal of record reveals the fact that accused/applicant has been ordered to join the investigation vide order dated 03.10.2025 passed by this court. Today, ASI Mukhtiar Singh has come present, who has suffered a statement that the accused/ applicant has already joined the investigation and his further custodial interrogation is no more required to the police. Accordingly, order dated 03.10.2025 is hereby made absolute, subject to conditions under Section 482 of BNSS, 2023. Consequently, present bail application moved by accused/applicant **Avtar Singh** is hereby allowed in above terms.

However, any observations made herein above shall have no effect on merits of the case. Police record be returned, whereas bail application file be consigned to Record Room after due compilation.
