I do hereby state on solemn affirmation that-

Examination-in-chief of witness by Adv. Smt. Apturkar for Petitioner.

1] I know deceased Uttam Kisnaji Shende. I have my own shop under the name and style as "Shree Electrical and Plumbing". I have received witness summons. Deceased was working with my shop. He was doing work of electrical and plumbing. Whenever there was work of electrician and plumbing, I used to call him and he used to come for it. He was working in the evening for the said work. In the day time, he was doing agricultural work. He was getting Rs.15,000/- to Rs.20,000/- per month for this work. I had issued the salary certificate. I am proprietor of Shree Electrical and Plumbing. It is now shown to me. It bears my signature. Its contents are true and correct. It is at Exh.60. I have attached my Aadhar Card with Exh.60. I have filed shop license. It bears my signature as a true copy. It is verified from original. It is at Exh.61. Deceased was very good in his work.

Cross-examination for Respondent No.1.

Respondent No.1 and his counsel absent when repeatedly called. Hence cross examination - Nil.

Cross-examination by Adv. Shri Aditya Joshi for Respondent No.2.

3] It is true to say that in Shop Act license Exh.61, there is a difference in my father's name. It is not true to say that there is a difference in address in Exh.60 & 61. It is not true to say that I do not possess any degree to work as a Electrician. Witness volunteers that I am

ITI in Electrical. It is true to say that I have not filed any document on record to show that I am proprietor of Shree Electrical. It is not true to say that mobile number mentioned in Exh.60 is not of mine. I have not filed statement of account of Shree Electrical. I was not giving salary to him. I do not know how much amount deceased was receiving from the customers from whom who was working as a Electrician. It is not true to say that deceased was not receiving Rs.500/- per day. It is true to say that I do not have any document to show that he was working with me. It is not true to say that I cannot say whether he was getting Rs.15,000/- to Rs.20,000/- per month. I maintain book of account of Shree Electrical. I have not filed books of account on record. It is not true to say that in order to help petitioners, I am deposing false. It is not true to say that I was not giving any work to him. Three to four persons are working with me like deceased. 40 to 50 customers per month comes to my shop for electrical or plumbing work. It is true to say that 4 to 5 persons working in my shop do not get equal work. It is not true to say that deceased was not receiving Rs.15,000/- to Rs.20,000/-. I maintain transaction of other employees. I have not maintained transaction of work of deceased in my shop.
