COMMITTAL ORDER IN REGULAR CRIMINAL CASE NO. 106/2026

Today, Accused No. 01 – Sameer Kamruddin Shaikh, Accused No. 02 – Aftab Kaleem Shaikh, Accused No. 03 – Ramdas Navnath Ubale, Accused No. 07 – Arjun Harishchandra Jagdale, Accused No. 29 – Kirankumar Bhaskar Rohokale, Accused No. 36 – Santosh Madhav Dhasal, and Accused No. 39 – Akshay Madhukar Nikam are produced before me at 4.00 p.m., by the Sub-Jail Authority, Jamkhed through the Police Constable Shri. I. B. Mane (B.K. 2663), Police Constable Shri. Y. D. Dalvi (B.K. 1427), Police Constable Shri. I. D. Pardeshi (B.K. 1446), Police Constable Shri. Dnyaneshwar Belhekar (B.K. 749), Police Constable Shri. D. R. Gange (B.K. 944), Home Guard Shri. Raban Nasin (B.K.2775), Home Guard Shri. Nasir Sheikh (B.K. 5524) and Home Guard Shri. Mohasin Sheikh (B.K.5214), all Jamkhed Police Station. The Learned Advocates for the accused persons are present before the Court.

02] Perused record and proceeding. On perusal, it appears that the charge-sheet against the accused Nos. 01, 02, 03, 07, 29, 36 and 39 has filed for the offences punishable under Sections 123, 274, 275 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023 and Sections 26(1), 26(2)(i), 57 and 59 of The Food Safety And Standards Act, 2006. The offence punishable under Section 123 of the Bharatiya Nyaya Sanhita, 2023 is exclusively triable by the Hon'ble Court of Sessions.

03] The copies of police report and other documents as specified under Section 230 of the Bharatiya Nagarik Suraksha Sanhita, 2023 have been supplied to Accused Nos. 01, 02, 03, 07, 29, 36 and 39. Therefore, in such circumstances, the present case will have to be committed to the Hon'ble Court of Sessions. This Court has informed the Sub-Jail Authority, Jamkhed to produce the Accused Nos. 01, 02, 03, 07, 29, 36 and 39,

before the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, Dist. Ahmednagar on 27/04/2026. Hence I pass the following order:-

1]	The case is hereby committed to the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, Dist. Ahmednagar.
2]	The sub-Jail Authority, Jamkhed has directed to produce the Accused Nos. 01, 02, 03, 07, 29, 36 and 39, before the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, Dist. Ahmednagar on 27/04/2026.
3]	The record of the case, along with all documents and articles which are to be produced in evidence, shall be sent to the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, Dist. Ahmednagar.
4]	The Police Station Officer, Jamkhed Police Station, is directed to produce the muddemal property, if any, before the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, District Ahmednagar, on or before 27/04/2026, without fail.
5]	The Public Prosecutor shall be notified regarding the committal of the case to the Hon'ble Court of Sessions, Shrigonda, Tal. Shrigonda, District Ahmednagar
6]	The copy of this order be forwarded to Sub-Jail Authority, Jamkhed.
