**ORDER PASSED BELOW BAIL APPLICATION
(Passed on 14th November, 2025)**

This is an application for bail moved by the accused under section 480 of the B.N.S.S. in connection with C. R. No. 337/2025 registered in the Mumbai Central railway police station for the offence punishable under section 317 (2) of the B.N.S.

2. Read the application. Accordingly, the say of Ld. A. P. P. and I.O. was called. They have filed their say and objected the application on the grounds that if the accused released on bail he would abscond. The accused would also pressurize the prosecution witnesses.

3. Heard the Ld. Counsel Shri. Govind Shetty for the accused. It is alleged that, the accused has purchased stolen Mobile handset of the informant without box and bill. The Mobile handset has been recovered. The investigation has been completed and the I. O. has also filed the Charge-sheet/final report against the accused. There is no material on the record to show that the accused is an habitual offender. It is also pertinent to note that the accused was not arrested by the I.O. during the course of the investigation.

4. Having regard to the nature of offence and stage of the case, if the bail is granted to the accused subject to certain conditions no harm or prejudice would be caused to the prosecution. Hence, I pass the following order :-

ORDER

1. The Bail application No. 506 of 2025 is allowed and disposed of.
2. Accused namely Dattatray s/o Yashwant Thore is released on bail on executing his P. R. Bond of Rs. 10,000/- (Rupees Ten Thousand Only) with local surety of the like amount.
3. Accused shall not tamper with the prosecution evidence and shall not make contact with any person known to the facts of the case and attend each and every date of hearing of the case till conclusion of the trial.
4. Accused shall submit authenticated copy of his identity and address proof.
5. Accused shall not indulge himself in the same kind of offence here-in-after.
6. Provisional cash bail of Rs. 6,000/- (Rupees Six Thousand Only) is allowed for Four weeks.

ORDER BELOW BAIL APPLICATION

This is an application for bail moved by the accused under section 480 of the B.N.S.S. in connection with C. R. No. 141/2025, registered with Mumbai Central railway police station, for the offence punishable under section 303 (2), 13 of the B.N.S..

2. Read the application. Accordingly say of Ld. A. P. P. and I.O. was called. I. O failed to filed his say. Hence, application proceeded without his say. Ld. Asst P. P. has submitted that his argument may be treated as heard.

3. Heard Ld. Counsel Shri Atul Pandey for the accused. Admittedly, the offence is not punishable with death or imprisonment for life. It is alleged that the accused has committed theft of mobile phone of the informant. The stolen mobile phone is recovered. Chargesheet is also filed against the accused.

4. Under the circumstances if bail is granted subject to certain conditions no harm or prejudice would cause to the prosecution. Hence, I pass the following order :-

ORDER

1. The Bail application No. 248 of 2025 is allowed and disposed of.
2. Accused viz. Suraj Chakrabahadur Damai be released on bail on his executing P. R. Bond of Rs. _____/-

- (_____) with local surety of like amount.
3. Accused shall not tamper with the prosecution evidence and shall not make contact with any person known to the facts of the case and attend each and every date of hearing, till conclusion of trial.
 4. Accused shall submit authenticated copy of his address proof.
 5. Accused shall not indulge himself in the same kind of offence here-in-after.
 6. Provisional cash bail of Rs. _____/-
(_____) is allowed for Four weeks.
