AWARD

This petition filed under section 166 of the Motor Vehicles Act, 1988 by claiming compensation for a total sum of ₹5,00,000/- (Rupees Five Lakhs only).

2. The petitioner and 3rd respondent settled the matter and filed a joint memo dated 08.08.2025. The compromise in the joint memo is recorded since it's terms are lawful. Hence an award is passed in terms of the compromise as follows:-

1. The petitioner is entitled to realise a sum of **₹4,75,000/- (Rupees Four Lakhs and Seventy Five Thousand Only)** as compensation for the injuries and loss caused to him in the motor vehicle accident from the 3rd respondent Insurance Company and it's assets. The 3rd respondent is directed to deposit the above amount in the SB Account No.00000042808052347 (IFS Code: SBIN0070880) of this Tribunal with the State Bank of India, Collectorate Branch, Kasaragod within one month from today by way of electronic funds transfer. After the said deposit by the 3rd respondent, the amount shall be deposited in a Nationalised Bank in the name of petitioner as a fixed deposit.
2. The joint memo of the petitioner and the 3rd respondent shall form part of the award.
3. The amount of full Court Fee and KLBF fee, if remitted, shall be refunded to the petitioner.
