ORDER:

1. The instant bail application has been filed under section 439 CrPC, praying for grant of regular bail to the accused/applicant in case FIR No.183 dated 9.7.2020 under section 21 of NDPS Act, registered at police station Rama Mandi, Jalandhar.
2. The allegation against the accused/applicant is that he was found in possession of 6 gram heroin on 9.7.2020.
3. The case of the accused/applicant is that he has been falsely implicated in this case and has committed no offence. Nothing has been recovered from the accused/applicant. The accused/applicant has been in custody since 9.7.2020. It was prayed that accused/applicant be released on bail.

4. While, on the other hand, learned Addl. PP for the State contested the bail application.

5. I have considered the rival submissions.

6. The alleged recovery of 6 gram heroin has already been effected. The accused/ applicant has been in custody since 9.7.2020. The presentation of the challan and conclusion of the trial will take its own time. No useful purpose will be served by keeping the accused/applicant in custody for an indefinite period. It is also not the case of the prosecution that if accused/applicant is released on bail, he would influence the prosecution witnesses. In view of these factual circumstances, the bail application of accused/applicant succeeds and he is directed to be released on bail on furnishing bail bonds in the sum of ₹40,000/- with one surety in the like amount, subject to the following conditions:-

- a) That he will not tamper with the prosecution evidence and will not offer any threat, promise or inducement, directly or indirectly to any of the person acquainted with the facts of the case, dissuading him from disclosing the same to the court/ investigating agency; and
- b) That he will not leave the limits of India without prior permission of the court.
- c) That he will appear in the court on each and every date of hearing.

7. Bail application file be attached with the remand papers.
