NO DISPUTE AWARD

1. Vide this award, I shall decide the reference dated 22.12.2016 in respect of the workman Sh. Prahlad s/o Sh. Lutaee Ram, sent to this court by the Dy. Labour Commissioner, West District, Labour Department, NCT of Delhi, bearing no. F.3(303)/16/Ref./WD/Lab./1121 with the following terms of reference:

“Whether workman Sh. Prahlad S/o Sh. Lutaee Ram, have been terminated illegally and/or unjustifiably by the management; and if so, to what relief is he entitled and what directions are necessary in this respect?”

2. Upon service of the notice of the reference, workman appeared in the court and filed statement of claim. Management was also served, who filed written statement. In the meantime, workman got issued corrigendum in respect of the name of the management. Thereafter, the matter got adjourned at the request of the workman for taking steps for further prosecution of the matter.

3. Thereafter, the matter was adjourned repeatedly for taking necessary steps for the service of the management, however, the workman did not take any steps to serve the management. Moreover, the workman also stopped appearing in the court.

4. Despite repeated opportunities given to the workman, the workman has failed to take any steps in further prosecution of its case. It seems that the workman is not interested in pursuing this reference. Thus, in the given facts and circumstances, “No Dispute Award” is passed against the workman.

5. The reference is answered accordingly.

6. The attested copy of the award be sent to the Office of the Deputy Labour Commissioner, Government of NCT of Delhi of Dist./Area concerned for publication, as per rules.

7. File be consigned to Record Room, after due compliance.
