M. Radha Vs Smt. Kamlesh

Sh. Suraj Rawat, Ld. Counsel for respondent, files Vakalatnama. Same is taken on record.

Ld. Counsel for respondent submits that he does not want to file reply and has no objection, if the application filed by the petitioner is allowed.

The present Transfer Petition has been filed U/s 24 of CPC for seeking transfer of Suit bearing No. 125/2022 titled as 'Radha Vs. Kamlesh', pending in the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi on the premise that petitioner has filed two suits against the respondent bearing Nos. 139/2022 titled as 'Kamlesh vs M. Radha' and 463/2021 titled as 'M. Radha vs Kamlesh', both pending in the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi, whereas one suit filed by the respondent against the petitioner i.e. Suit bearing No. 125/2022 titled as 'Radha Vs. Kamlesh' has been assigned to the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi.

It is contended that the issue involved in all the suits are all the more same. The dispute between the parties in all these suits is also the same, therefore, the suit being No. 125/2022 titled

as 'Radha Vs. Kamlesh' pending in the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi may be transferred to the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi.

I have heard Ld. Counsels for the parties and perused the application. Vide this application, petitioner has sought transfer of Suit bearing No. 125/2022 titled as 'Radha Vs. Kamlesh' pending in the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi to the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi, where two other suits filed by the petitioner against the respondent are pending.

The issue involved in all these suits are connected with each other. The parties in all these suits are also same, therefore, it would be in the interest of justice, if the suit being No. 125/2022 titled as 'Radha Vs. Kamlesh', filed by the respondent against the petitioner, pending in the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi is also assigned to the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi.

In view of the above, the petition filed U/s 24 of CPC is allowed. Suit bearing No. 125/2022 titled as 'Radha Vs. Kamlesh' is withdrawn from the Court of Sh. Anubhav Jain, Ld. DJ-05, New Delhi District, Patiala House Court, New Delhi and assigned to the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi.

Parties are directed to appear before the Court of Ms. Meenu Kaushik, Ld. DJ-03, New Delhi District, Patiala House Court, New Delhi on **15.07.2026** at **02.00 pm**.

Ahlmad concerned is directed to send the file to the transferee court forthwith. Copy of this order be sent to the Courts concerned.
