It is ordered that the suit of the plaintiff succeeds and is hereby decreed exparte with costs to the effect that the plaintiff is entitled for the recovery of Rs. 5,09,028 /- from the defendant alongwith interest at the rate of 10.25% per annum from the date of filing of the suit till its realization with future interest at the same rate on principle amount and composite decree for recovery of the above stated amount is passed against the defendant after selling the hypothecated/mortgaged property and if the fruits of the sale of hypothecated/mortgaged property remain unsatisfied the decreetal amount then defendant would be personally liable for payment of the balance decreetal amount. Further, defendant is directed to pay the amount referred above within 02 months alongwith interest.
