**THE STATE GOVT OF NCT OF DELHI Vs. GAURAV
RAM and ANR.**

Accused Gaurav Ram (on bail in present case) is
produced from JC.

Accused Shailender Kaur not produced from JC.

Perusal of the charge-sheet reflects that on 24.12.2024, during routine patrolling in Sagarpur Area, Delhi, the accused Gaurav Ram was apprehended with 12 *pudiyas* of *heroin*, weighing 1.36 grams of *heroin* was recovered. Thereafter, during the interrogation accused Gaurav Ram had disclosed that the source of the said contraband was accused Shailender Kaur and he used to work at the behest of the said accused, for selling the same. On 31.12.2024, accused Shailender Kaur was apprehended and from one black color polythene, being carried by her, 7.62 grams of *heroin*, was recovered. The proceedings U/s 52 A were duly conducted before the Ld. JMFC on 17.11.2025.

Although, the FSL result is still awaited, however, the charge-sheet is a complete charge-sheet and there is enough material, on the basis of which, this Court can take cognizance. Reliance is placed on the decision of the Division Bench of Hon'ble High Court of Delhi "*Rahimullah Rahimi Vs. State of*

Prima facie, the commission of offence punishable u/s 21 (a) r/w Section 29 of NDPS Act is made out against both the accused persons and commission of offence punishable U/s 21 (b) of NDPS Act is made out against accused Shailender Kaur. I hereby take cognizance of the offence.

Copy of charge sheet be supplied to accused Gaurav Ram against due acknowledgment. Same be also supplied to accused Shailender Kaur through concerned Jail Superintendent.

Let fresh production warrants be issued against accused Shailender Kaur for the next date of hearing along-with the direction to the concerned Jail Superintendent to file written explanation as to why the accused was not produced today.

Report has been filed by the IO qua the status of the FSL result and as per the said report, the result is still awaited and as per the communication received from FSL Rohini on 19.01.2026, it was informed that the samples were sent to FSL Chandigarh for examination and result is still awaited. IO is directed to take steps to get the priority letter issued through DCP concerned.

Now to come up for filing of the FSL result and further proceedings on **23.03.2026**.
