ORDER

1 Vide this order, I shall dispose off the present bail application u/s 483 BNSS, 2023 seeking interim bail for a period of 90 days.

2 It is submitted by Ld counsel for applicant/accused that there is no other application seeking similar relief is pending before the Hon'ble Supreme Court of India, Hon'ble High Court of Delhi or any other court.

3 It is submitted by Ld counsel for applicant/accused that the applicant/accused was released on interim bail on 27.06.2025 till 04.07.2025 on medical grounds. The medical documents of the accused/applicant was sent for verification. NCB has filed the verification report and the medical documents of the applicant/accused have been duly verified from Sir Ganga Ram hospital, New Delhi.

4 Perusal of record reflects that the applicant/accused has been granted interim bail on medical grounds by the Hon'ble High Court of Delhi vide order dated 02.04.2025 and same was extended from time to time, till his surrender on 07.04.2025. The present application was moved before the Ld. Vacation Bench

and vide order dated 27.06.2025, he was granted interim bail till the NDOH.

5 In view of the verification report received, the present application is hereby allowed and the applicant/accused is admitted to further interim bail for a period of 90 days. The previous bail bonds/surety bonds shall continue. The applicant/accused shall continue to abide with the conditions imposed vide order dated 27.06.2025 and he shall surrender on or before expiry of interim bail period of 90 days.

6 Needless to say that nothing expressed herein shall have any bearing on the merits of the present case.

The application is disposed off accordingly.
