**ORDER.**

1. This is an anticipatory bail moved on behalf of  
applicants/accused Sawinder Singh alias Jindu in case FIR NO.93  
dated 25.10.2018, under Section 61/1/14 of Punjab Excise Act, P.S.

Ghuman.

2. On 12.11.2018, this Court granted interim relief to applicant/accused by passing following order:-

*1....“ This is an anticipatory bail moved on behalf of applicants/accused Sawinder Singh alias Jindu in case FIR NO.93 dated 25.10.2018, under Section 61/1/14 of Punjab Excise Act, P.S. Ghuman.*

- *Brief facts of the case are that on 25.10.2018, applicant/accused was found in possession of 50 Kgs of lahan without any permit or license.*
- *Contention of Sh. D.S.Mattu, Adv, Ld. Counsel for applicants/accused is that applicant/accused has been falsely implicated in the present case. He argued that alleged recovery if any has already been affected. Identity of applicant/accused is also in dispute. He argued that applicant/accused is ready to join investigation and co operate with the Investigating Agency.*
- *Adjourned to 21.11.2018*
- *Accordingly, in the meantime applicant/accused is directed to join investigation and cooperate with the IO. In the event of arrest of applicant/accused,*

*he is ordered to be released on interim bail on his  
furnishing bail bonds and surety bonds to the  
satisfaction of IO/Arresting Officer, subject to  
conditions laid down Under Section 438(2) Cr.P.C.*

”.

3. Today ASI Gurmeet Singh, I.O came present to record his statement to the effect that applicant/accused has joined investigation and his custody is not required in the present case.
4. In view of this, interim order dated 12.11.2018 whereby applicant/accused was ordered to be released on interim bail on his furnishing bail bonds and surety bonds to the satisfaction of IO/Arresting Officer, subject to conditions laid down Under Section 438(2) Cr.P., is hereby made absolute.
5. Police record be returned and file be consigned to record room.
