Since PW/patient Raj Kumar was discharged from hospital on 08.10.2021 itself, I find no merits in the application in hand seeking exemption from personal appearance of PW Raj Kumar. However, a lenient view in the matter is taken and PW Raj Kumar is exempted from personal appearance for today only. PW Raj Kumar is directed to appear in person on NDOH without fail.
