ORDER BELOW EXHIBIT: 1 WITH EXHIBIT:15

1. Today, Saturday - 12.03.2022 National Lok Adalat for MACP cases is held. The concerned parties and their Learned Advocates are present before the Tribunal. Heard.
2. The compromise pursis Exhibit:15 is read over to parties, they agreed to the terms and conditions of the compromise. The Claimant/s has prayed to restrict the claim amount upto Rs.1,05,000/-. Hence, compromise pursis is deem as legal, just and bonafide. It deserves to be recorded, considering the Motor Vehicle Act with the object of the legislature as the present law is based on the social welfare scheme and to compensate to the victim person. The Tribunal has also considered the preamble of Lok Adalat. Hence, following order is passed:

:: O R D E R ::

1. The compromise pursis Exhibit:15 is recorded.
2. The claim petition is allowed, as per Compromise pursis.
3. The Opponent/s (Insurance Company) is hereby directed to deposit **Rs.1,05,000/- (Rupees One Lakhs Five Thousand only)**, as full and final payment, as per the compromise pursis Exhibit:15 accordingly, into the Bank Account maintained by this Tribunal by RTGS or NEFT mode, after deducting the amount of interim compensation, if any, paid under section 140 of the Motor Vehicles Act, 1988, as full and final payment, as per the compromise pursis vide Exhibit:15. The Claimant/s are permitted to restrict the claim upto **Rs.1,05,000/-** and the remaining amount is hereby waived.

4. It is further directed that after depositing the compensation amount, the Opponent/s (Insurance Company) will communicate the factum of the deposit forthwith / expeditiously to this Tribunal with a copy to the beneficiaries. Opponent/s (Insurance Company) are further directed to comply the direction given by the Hon'ble Supreme Court in Writ Petition(s) (Civil) No.534/2020.
