ORDER:

1. Bail application of accused/applicant under section 438 CrPC is considered.
2. Accused/applicant is apprehending his arrest for the offence under section 379,413,414,411 IPC
3. The case of the prosecution is that accused/applicant is habitual in receiving the stolen property. It has been specifically come in the investigation that non accused/applicant used to sell the laptop to him.

One laptop was recovered from non accused/applicant and other laptops were sold to the accused/applicant.

4. The case of the accused/applicant is that stolen laptop has been recovered from the non accused/applicant. The accused/applicant has been falsely implicated. A false case has been imposed.

5. While, on the other hand, learned PP for the State contested the bail application by submitting that recovery is yet to be effected. The accused/applicant is habitual in receiving the stolen laptop.

6. I have considered the rival submissions.

7. There is a prima facie allegation against the accused/applicant that he is habitual in receiving the stolen laptop. The recovery is yet to be effected. The accused/applicant is said to be working in a *Ahata*. Keeping in view the gravity of the offence and nature of the allegation, an exceptional case for granting the pre arrest bail to accused/ applicant is not made out. Therefore, the bail application of accused/applicant is dismissed. Bail application file be consigned to the record-room.
